

The Dad Effect: Engaging Fathers in Their Children's Lives and in Home Visiting **RESOURCE Guide**

Father-Friendliness

- Reflect on your attitudes and beliefs about fathers to identify biases that could affect your ability to engage fathers in their children's lives and in home visiting.
- Assess your "father-friendliness" and set goals for positive changes.
- Invite and welcome dad into your home visits.
- Get direct contact information for dad and avoid using mom as a go-between.
- Learn to know dad as an individual, with an attitude of cultural humility.
- Be flexible with appointment times and locations of home visits.

Engaging Dad in His Children's Lives

- Provide dad with father-friendly resources and activities.
- Teach dad about his importance to his family and to his child's development.
- Help dad identify ways he is already a good dad.
- Focus on skill development to support his child's school readiness.
- Ask dad how he would like to be involved/engaged with his child.
- Help dad overcome barriers to involvement/engagement with his child.
- Support dad in strengthening protective factors.
